ORDER U/S 12 A OF THE INCOME – TAX ACT, 1961

DATED, BHAGALPUR, THE 13th February, 2003

The organisation viz. "Gramin Vikas Evam Seva Sansthan", Dhiranpuri, P.O.- Matia, Dt. - Jamui was established by the trustees/ deed of incorporation on 26-04-1996 and registered under Indian Trust Act, 1882 on 25-10-1996. The application for registration u/s 12A of the Income tax Act, 1961 was filed in the prescribed proforma on 10-10-2002 before Commissioner of Income-tax, Bhagalpur. The application was not within time but the delay is condoned. On enquiries and examination of the documents, the trust was found to be existing and carrying on its stated objectives. I am satisfied that it fulfills the conditions laid down u/s 12A in the Income – tax Act, 1961 for registration u/s 12A. Hence, the trust is hereby granted registration u/s 12A of the I.T. Act, 1961 with effect from the 01-04-2002. Relevant entry has been made in concerned register vide serial no. 19.

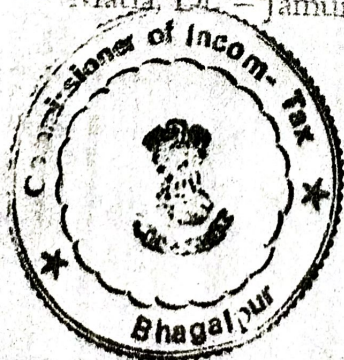

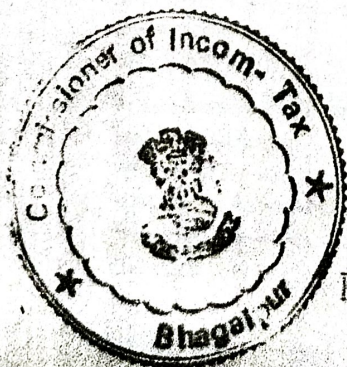
